



NEW CLIENT COACHING AGREEMENT

COMMITMENT:

- Both Client and Coach agree to bring our best selves to each coaching session.
- The Client understands that personal/professional growth is limited by his/her commitment and participation in the coaching relationship. The Client agrees to proactively seek support when needed.
- The Client understands that the Coaching relationship is collaborative in nature. Both parties will communicate with authenticity, honesty, and from a place of personal power.
- The Coach views the Client as creative, powerful, and resourceful. The Client will act from this premise and is responsible for his/her actions and success. Not accepting personal responsibility is grounds for dismissal from the coaching relationship. Client is still responsible for any balance due.
- The Coach will listen without judgment, support the Client's goals, hold the Client accountable, and provide positive, encouraging feedback.
- The Client understands that coaching services are not a substitute for mental health care, which Rene Dunnagan (Your Solutionator) does not offer. If Psychotherapy is needed, the Client agrees to seek such professional assistance.
- The Coach is dedicated to the Client's success.
- The Client agrees to complete assigned homework in the agreed upon time-frame and understands that non-completion may slow the Client's progress.
- The Coach and Client will celebrate achievements and work through obstacles together.

COACHING SESSION PROCEDURES:

- Each coaching session will take place via phone unless agreed upon previously. The Client will call Rene Dunnagan at **970-999-2303** at the agreed upon time.
- Both Client and Coach agree to show up on time at the mutually scheduled session and eliminate distractions before the coaching session begins.

CONFIDENTIALITY:

The coaching relationship is built on trust and all conversations held within our coaching sessions are confidential and will be protected as such.

EXCEPTIONS TO CONFIDENTIALITY:

- If Business Coaching is provided and the Client wishes the Coach to share marketing-type information with others, the Client agrees this is a satisfactory exception to the confidentiality agreement.
- On occasion I may need to confer with a coaching colleague in order to provide the best solution to my client’s obstacles. I reserve the right to do so when it is in the best interest of my client but will keep identifying information confidential.
- The following instances obligate me to break our confidentiality agreement without permission and report information to Law Enforcement and/or family members.
 - If it is assessed during our coaching sessions that abuse or neglect of children, elders or animals is occurring.
 - If in my presence you threaten to kill or harm yourself or another individual.
